Request for return of LVTS funds (recall, cancellation or amendment)	Minimum of \$35.00 Canadian Payments Association fee, plus out of pocket expenses
Investigations commencing within three months of original transaction date	\$35.00 plus out of pocket expenses
Investigations commencing after three months, but within twelve months of original transaction date	\$55.00, plus out of pocket expenses
Investigations commencing more than twelve months after the original transaction date	\$120.00, plus out of pocket expenses

Foreign Currency Payments

Unless otherwise instructed, payments expressed in a foreign currency and payable at BMO Financial Group, will be paid at BMO Financial Group's current buy rate for demand drafts on the country of currency.

Value Dating

Where the value is requested for date prior to date of receipt of instruction:

- For CAD Payments CAD 300.00 (plus out of pocket)
- For US Payments USD 300.00 (plus out of pocket)

- Instructions received by 15:00 Eastern Time for payment in Canada will be valued the same day.
- Instructions covering payments to points outside of Canada received by 15:00 Eastern time will be effected the same date for value in accordance with conditions prevailing at the location of the account with institution.
- Value dating is subject to local practice.
